### 2015-2016 SELECTIVE SERVICE REGISTRATION

The Department of Education has informed us that you are not registered for Selective Service. Most male students must register with Selective Service to receive federal aid. See PART 1 for information on how to register or PART 2 to explain and present proof of reason for non registration. Please return this form to the Financial Aid Office indicating your actions.

#### PART 1. To Register for Selective Service

There are four ways to register for Selective Service. Please check the appropriate statement:

- I would like the Financial Aid Office to update my FAFSA by selecting "Register Me."
- I will use the Free Application for Federal Student Aid (FAFSA) and select "Register Me" at the Selective Service registration question.
- I will register online at [www.sss.gov](http://www.sss.gov) and then submit proof of registration to the Financial Aid Office.
- I will fill out the Selective Service registration form at the local Post Office and submit a copy of the registration card to the Financial Aid Office.

#### PART 2. To Explain and Present Proof of Reason for Non Registration

In order to receive financial aid, you must prove one of the following situations applies. Please check the appropriate statement:

- I did not register for Selective Service because I was not within 30 days of turning 18 years of age when I completed my FAFSA.
- I am not required to register because I am female.
- I am not required to register for Selective Service because I was born before 1960.
- I am currently serving on active duty in the U.S. Armed Forces. *Please submit proof of service.*  
(A student who is in the National Guard or Selected Reserves and not on active duty does not meet this exemption.)
- I served on active duty in the U.S. Armed Forces until after I turned 26. *Please submit a copy of your DD-214 form.* (A student who was in the National Guard or Selected Reserves and not on active duty does not meet this exemption.)
- I am/was a non-citizen who entered this country after the age of 26. *Please provide a valid document such as a passport that verifies the date of entry to the United States.*
- I am/was a noncitizen who entered the U.S. as lawful nonimmigrant on a valid visa and remained in the U.S. on the terms of that visa until after I turned 26. *Please provide proof of this statement.*
- None of the above statements apply to me. Students who are not clearly exempt from the registration requirement must submit a *Status Information Letter* from Selective Service ([www.sss.gov](http://www.sss.gov)) and provide a statement of explanation of non registration. NCC Financial Aid may require more information from you and will make a determination on your eligibility after a review of all the information.

I/We certify that the above information about Selective Service is complete and correct. I/We understand that the information on this form may require further follow up from the Financial Aid Office. By signing this form, I/we certify that all of the information reported to qualify for Federal Student Aid is complete and correct. If I receive financial aid based on false or misleading information, I will be required to return the funds.
